Fort Edmonton Park Volunteer Profile: Leah Cline-Veneau

The Strict School Marm with a Heart of Gold

The Park has a strange magic to make otherwise torturous chores - washing socks, beating rugs, dusting - into thrillingly fun and meaningful activities, and at the same time to disguise the most charming, sweet people into the villians and rogues of the past. No one more relishes this mysterious switch than Leah Cline-Veneau, who manages to disguise her big heart and sweet nature to become the strict School Marm on 1885 Street each summer.



Leah has always been a history enthusiast and became a volunteer in 2013. The following


summer, she brought along her son, Chris, making three generations of family involvement (her Aunt worked here and an Uncle was a long standing member of the Edmonton Radial Railway Society driving the streetcars). "It just feels like I've always been here," Leah muses, "and now I feel a little befuddled when I'm not volunteering at the park! For me, and for Chris, this is a community and a de-stressor". She's so proud of the growth she's seen in her son, who has developed noticeable confidence as a result of his engagement. "It is just an amazing thing for him, the friends he's made here".

For Leah, being part of the community at the Park has been a transformative experience to her sense of identity. "I've always felt like an outsider", she confides, "but here I not only feel included, I feel important and valuable." Leah shares that growing up she struggled, especially in school, with an undiagnosed learning disability that left her feeling excluded and insignificant. Being at Fort Edmonton was a turning point; "I remember telling my supervisor Lacey about my disability, and she just gave me a hug as told me I was her friend and this did not define me." From then on she felt empowered her to find her strengths and to ensure that this continues to be a comfortable place where everyone is welcome. In Leah's words: "Here I feel safe and I feel accepted for who I am."

Leah figures that is why she takes such pride in her school lessons: since it's "play," the children *enjoy* the character of the strict teacher. It gives her an opportunity to start a conversation about the differences in education then and now, and to help children of all learning styles enjoy and participate in the activities. With her unique sensitivity to their experience, Leah can make something special: "If I make one child interested in a piece of history, I've done my job". She's also received compliments from real teachers on field trips, who are entertained by how effectively she uses "historic" discipline methods. She was horrified when a child cried in remorse for misbehaving in her lesson, "but the teacher came up at the end of the lesson to thank me", she laughs, "for finally getting through to the little terror who hadn't listened all year."

Shortly, Leah will transform again, from her Spooktacular role as Anne Boleyn's disembodied head, into Mrs. Rutherford as part of our Christmas Reflections programming. Join her community of volunteers for this lovely Holiday event!

Giving Tuesday: December 1st, 2015

Did You Know: Charitable Giving Options

Making a charitable donation is not limited to writing a cheque and dropping it in the mail. These days, there are numerous ways to support your favourite charity that go beyond the cheque book. Here are a few different charitable giving options that can also offer additional tax saving benefits.

Donation of Securities

When you own publicly traded securities that have appreciated in value, there is a tax liability on the capital gain at the time of sale of the security. Once the security is sold, 50% of the capital gain must be reported as income. Depending on the appreciation in value of the security, the liability may be substantial. However, if a publicly traded security is donated to a charity instead of being sold, the capital gain that is reported is reduced to zero.

Corporate Gifts

When a corporation makes a charitable gift, the corporation receives a tax deduction, which reduces its income and therefore tax payable. The limit on the amount of the charitable donation that may be claimed in a given year is 75% of net income. If the credit or deduction is not used, it can be carried forward for 5 years. It should be noted that capital gains are also eliminated for corporate gifts of publicly traded securities, making them an ideal and tax efficient source of funding for charitable gifts.

The key difference between giving personally vs through a private corporation is that private corporations have a notional account called the Capital Dividend Account (CDA). The existence of this account creates a financial planning opportunity which makes a charitable gift through a corporation particularly attractive.

First-time Donor's Super Credit (FDSC)

From Revenue Canada: the First-time donor's super credit (FDSC) supplements the value of the charitable donations tax credit (CDTC) by 25% on donations made after March 20, 2013, by a first-time donor. You are considered a first-time donor if neither you nor your spouse or common-law partner (if you have one) have claimed and been allowed a charitable donations tax credit for any year after 2007.

The FDSC applies to a gift of money made after March 20, 2013, up to a maximum of \$1,000, in respect of only one taxation year from 2013 to 2017. If you have a spouse or common-law partner, you can share the claim for the FDSC, but the total combined donations claimed cannot be more than \$1,000.

Life Insurance

This is the second most widely used type of planned gift in Canada. A current gift of life insurance involves a transfer of ownership of the policy to the charity. The insured can pay the annual premiums of the policy and receives a tax receipt for that amount each year. The charity owns the death benefit and any cash surrender value in the policy. A deferred gift of life insurance names the charity as the beneficiary of the policy.

Charitable Remainder Trusts

These are trusts that pay income to the donor, or beneficiaries, for life or a set term. Upon death of the donor or beneficiaries, or at the end of the term, the charity receives the amount that remains in the trust.
